## **National Standard for Organic and Biodynamic Produce**

- Accredited by the Department of Agriculture Water & the Environment
- The National Standard for Organic and Bio-Dynamic Produce (referred to as the Standard)
  was first implemented in 1992 as the Australian Export Standard for products labelled
  organic or bio- dynamic.
- No levies are attached to this Standard
- The National Standard is a mandatory requirement for exporting Organic produce.
- Provides market access to regulated countries such as the EU, Japan & Taiwan (for most products), as well as unregulated countries in Asia, the Middle East and many more
- Eligible products can use an ACO Logo <u>and/or</u> the "National Seal" (pictured below)

- Privately owned and published by the Organic industry not-for-profit peak body, Australian
   Organic Limited
- The ACOS provides additional market access to the EU for livestock, wine and products containing imported ingredients.
- The ACOS is also a mandatory requirement for IFOAM certification
